In addition, the improvements made to the yard will create safer and more frequent service for all Red Line riders through increased capacity, improved reliability, reduced noise and light pollution, and upgraded safety.

## **Codman Yard Expansion and Improvements**

## **Project Overview**

The improvements at Codman Yard will allow crew members to move trains throughout the yard more efficiently, increase service frequency, and create additional vehicle storage for the future expanded Red Line fleet.

## Benefits

- ✓ Increased Capacity: expanding the yard by six tracks will create additional space to accommodate the future Red Line fleet
- Improved Reliability: replacing yard components will improve safety, service frequency, and reliability, reduce maintenance costs, and achieve a state of good repair
- Reduced Noise & Light Pollution: replacing track will reduce noise as trains move throughout the yard and upgraded lighting will reduce unwanted light spillover into adjacent residential neighborhoods
- ✓ Upgraded Safety: Improving the fence around Codman and upgrading security cameras will create a safer yard for employees and neighboring areas
